Father/Son/Daughter Day with Peter Wilt

The March 14th luncheon is our annual Father/Son/Daughter Day. As in many March meetings, our program has a sports theme, with a presentation by veteran American soccer executive Peter Wilt.

His presentation will be on the history of professional soccer in Chicago covering more than 50 years of the sport predating the Chicago Sting through today's Chicago Fire and Chicago Red Stars. Wilt will talk about the men's and women's World Cup matches played in Chicago, the four pro soccer teams he personally ran in Chicago and the players, coaches and owners who helped grow the game in the city. He'll also highlight some of the great Norwegian players who have made their mark in Europe and one who played professionally right here in Chicago.

Peter Wilt has launched more professional soccer teams than anyone else.



Among his seven start-ups are the Chicago Fire Major League Soccer team and the Chicago Red Stars professional women's soccer team.



Job Posting: Treasurer

Last month, the Chicago Torske Klub announced the retirement of Ken Nordan and the opening for a new treasurer last month. Ken and wife Julie have purchased a home in Arizona and will be transitioning there over the next months. As such, we are re-emphasizing the request for one of our 100+ members to step up and volunteer as treasurer. We don't ask much of our members, in fact, one of the benefits is to 'just come and enjoy". That said, a few of us need to plan and participate and work a bit to make the luncheon a success. Most of those folks are listed at the bottom right of this page. It may discourage you that most of the board have been doing this for so long, but in fact, the effort is relatively minor and we have enjoyed it.

To that point, a treasurer does not mean a long term commitment by you. We have asked most officers to do the job for one Torske season (9 luncheons) and step down if they wish. Most have not. You may think you are committed to be at every luncheon; in fact, we step in and substitute for each other frequently as other commitments arise. As treasurer, you will be appointed to the board of directors, which is a one or two meetings per year. A financial background is not required. We are not chartered or incorporated; just a bunch of guys getting together for dinner. Our bank balance has been stable for decades. The treasurer duties typically include:



- Sit at the entry table from about 11:45am-1pm to receive payments and make change; the secretary handles reservations and checks in people.
- Write a check for the dinner, the incidentals (secretary mailing, raffle prizes) at the dinner.
- Make a deposit into the checking account after the dinner
- Optionally, receive the yearly dues to your address and add to the monthly deposit. This could be apportioned to another member if needed.
- Report on financials to the board at meeting: you don't need to be a CPA, this is essentially the checking account register.

Benefit: Your monthly dinner is paid, and you usually have drinks purchased for you by others. The money box is provided. Any costs are paid by the Torske Klub.
